### January

Teams may add the 4 weeks of January to their season contract for \$140.

1. Practice time slot is on a “First Come, First Served” availability.
2. Teams must complete a practice application agreement.
3. Season practice time must be paid in full within 7 days of booking practice slot or slot may be given to another team. Payment may be made by check, cash, credit card at the park or you may make a credit card payment through PayPal.
4. Teams booking practice time at All-tournament Players Park are required to have valid and sufficient medical/accident team insurance coverage and accept full responsibility for provision of coverage as a condition of facility use. Primary medical/accident insurance must be in effect for the entire term of the teams facilities use. Team must provide the park with proof of coverage. No practices may begin without insurance.
5. All coaches and team members (parent or guardian) must complete and sign the All-Tournament Players Park waiver. No non-team members are permitted on courts/fields.
6. Coaches are expected to respect time slots. Fields are not available prior to or after time slot. Teams are asked to end practices on time so as not to delay the following practice.

### RESCHEDULING POLICY

All-Tournament Players Park will work with teams to accommodate occasional needs to move practices. However, if there are no alternate practice times available court/field time practices can not be rescheduled. Practice times cannot be carried over into the next week.

1. Season practice time assumes 1 field – 1 team.
2. Practice games/scrimmages are not permitted during these practice slots. Practices are limited to team members only.
3. Actual closed holiday dates can be rescheduled within 10 days of that holiday date - as available.
4. All-Tournament Players Park will make every effort to make fields available after inclement weather. Closed fields will be indicated on the website on the game delay page.
5. All-Tournament Players Park reserves the right to consult with the coaches and/or administrators and move practice time to a mutually agreed upon time in the event of a conflict with large events. If both parties make every effort to come to a mutually agreed upon arrangement and an agreement can not be reached All-Tournament Players Park will refund the prorated amount, commensurate with the price per hour paid.

Teams booking practice time at All-tournament Players Park are required to have valid and sufficient medical/accident team insurance coverage and accept full responsibility for provision of coverage as a condition of facility use. Primary medical/accident insurance must be in effect for the entire term of the teams facilities use. Team must provide the park with proof of coverage. No practices may begin without insurance.

If both parties make every effort to come to a mutually agreed upon arrangement and an agreement can not be reached All-Tournament Players Park will refund the prorated amount, commensurate with the price per hour paid.
