GENERAL POLICIES & REGULATIONS FOR FIELD AND COURT USE

1. Group or individuals using the facilities for games, practice or other events hold All-Tournament Players Park free and clear of any and all claims for damages or loss of property that may result from any act or omission of the applicant and his/her agents, while on All-Tournament Players Park property.
2. Group or individuals using the facilities must sign appropriate All-Tournament Park waivers prior to using facilities.
3. All groups must maintain current insurance at their own expense and provide proof of said insurance.
4. Rental use is limited to contracting team or individual. It may not be "loaned out" to or shared with others at any time for any purpose. Additional teams will incur additional expenses.
5. Teams must provide adequate adult supervision of all children present. Misuse of facilities or lack of supervision of any child present, to include those family and friends who accompany the participant, can result in cancellation of future rental times.
6. All organizations, teams and/or individuals utilizing the facilities must leave them in satisfactory condition. Failure to do so will result in additional maintenance or actual repair cost being charged to your organization, group, or individual responsible.
7. Coaches will be responsible for not permitting non-players or non-coaches on fields, courts or in "coaches/players only" areas. Individuals not on team insurance should not be on court/field.
8. Renter is responsible for leaving facilities clean following events/practices.
9. When reserved time slot is complete it is the responsibility of the coach to leave the field or court at the allotted time. Continuing to play after scheduled time may result in additional charges.
10. Players should not be left without parent or guardian supervision at any time. Any player left unsupervised by a parent/ guardian is the responsibility of the coach. Coaches are required to remain with any player left under his supervision at the end of practice.
11. No person shall engage in any sale of merchandise or services, to include coaching or lessons, without permission of All-Tournament Players Park.
12. A \$25 return check fee will be charged for returned checks along with cancellation of rental agreement.
13. If payment is not received on or before due date indicated on the invoice, All-Tournament Players Park reserves the right to cancel rental agreement.
14. All-Tournament Players Park reserves the right to cancel a practice time when necessary for tournaments or other events. Credit will be given to contracting team or individual to be used toward future facility uses.
15. In the case of inclement weather, field playability is at the sole discretion of All-Tournament Players Park.
16. In the case of inclement weather during outdoor practices/games coaches are expected to follow the inclement weather guidelines by FEMA. Practices/games in progress may be canceled as a result of inclement weather if the management deems necessary. No refunds will be made.

Failure to comply with stated policies and guidelines may result in cancellation of future facilities rental.

Rescheduling Policy - All-Tournament Players Park will work with teams to accommodate occasional needs to move practices. However, if there are no alternate practice times available block court/field time will be charged for regularly scheduled time.

Rental use **is limited to contracting team** or individual for the purpose indicated. It may not be “loaned out” to or shared with others at any time for any purpose. Additional teams will incur additional expenses.

I understand that I am responsible for **any minor left unsupervised** by a parent/guardian.
